# **<u>RECOMMENDATION</u>**:

It is recommended that the Yolo County Transportation District (YCTD) Board of Directors conduct a public hearing to receive testimony regarding the proposed suspension of Yolobus Routes 43, 43R, 45 and 230, consider the testimony, and consider approving the route suspensions effective September 22, 2021.

# **REASON FOR RECOMMENDATION:**

On September 1, 2021, YCTD staff received notification from our contracted operations and maintenance provider, Transdev, that they would not have sufficient drivers to operate the planned Route 42 service expansion that was scheduled for September 12, 2021. Transdev also informed YCTD staff that they anticipated having an insufficient number of drivers needed to provide Unitrans Routes A, L and Z operating assistance to the City of Davis and UC Davis at the level that YCTD had previously committed to. The Unitrans A, L and Z operating assistance was scheduled to start on September 22, 2021.

More information regarding the Transdev staffing shortage was provided at the September 13, 2021 YCTD Board meeting, including causes of the shortage and strategies that are being considered and implemented to increase driver recruitment and retention. In the meantime, planned service levels need to be reduced to a level that can be reliably operated using existing staffing levels.

Toward that end, YCTD has delayed the launch of the expanded Route 42 service indefinitely and intends to provide a reduced level of Unitrans operating assistance (see Item 7 for details). Even with those reductions in planned service, YCTD needs to further reduce service, otherwise it is likely that bus trips will be missed and service will be unreliable. Rather than having unreliable service systemwide, staff recommends that Yolobus Commute and Express routes 43, 43R, 45 and 230 be temporarily suspended until staffing levels are such that those services can be operated reliably.

# **BACKGROUND**:

YCTD staff considered multiple factors when deciding which services to reduce or suspend. The following are the key considerations that led to these recommendations:

• **Minimize number of people impacted.** It is inevitable that some riders will be negatively impacted by service reductions. Staff's goal was to minimize the number of people impacted, so we evaluated historical and current ridership for each of the Yolobus routes as well as the anticipated ridership on the Unitrans Routes A, L and Z, which YCTD had previously committed to temporarily operating in response to Unitrans' own driver shortage. The results of this analysis are shown in Figures 1 and 2.



## Figure 1. Anticipated Daily (Weekday) Ridership by Route

- Ensure alternative options. Another consideration was to make sure that, when services were recommended for suspension, there were alternative public transportation options for the suspended routes. This is a particularly important equity consideration for transit-dependent populations. Figures 2, 3 and 4 provide detail on the alternative public transportation options for the customers whose Commuter/Express routes are proposed for temporary suspension.
- Use driver resources efficiently. A final consideration was to use our limited driver resources as efficiently as possible. Because the Yolobus Commuter and Express routes operate only during peak hours when driver resources are most scarce, and also primarily serve customers in a peak direction—often "deadheading" or traveling without customers back to the yard or to another route after just a single Commuter/Express trip—it makes sense from an operational perspective to suspend those service temporarily.

YCTD staff has already begun conducting outreach about the possible service suspensions, including posting a public hearing notice in the newspaper, posting information on social media, emailing the Yolobus mailing list, placing "seat drop" flyers on all routes that may be temporarily suspended (43, 43R, 45, 230), and posting signage at bus stops along the routes.

All public comments that have been received to date are included in Attachment A.

If the Board approves the recommendations tonight, this public outreach will continue to make sure that all riders are aware of any upcoming changes before the effective date, which is proposed for September 22, 2021.

## Attachment A – Public Comments Received as of September 16, 2021

I am reaching out to you regarding the September 20th hearing on whether to temporarily suspend the Yolobus commuter routes. While I understand that this may be a necessity, I am strongly opposed to it. I rely on the 43 Davis commuter to get to and from work, and it is very helpful for me. It is a great alternative to driving to work regularly. That said, I understand that it is always easier to complain about something, rather than being part of the solution. I have reached out to four different elected officials via email and mail regarding the bus driver shortage, and I will attach the letters in this correspondence.

Good Evening. I am a resident of Woodland and I regularly take the 45 to get to my job in downtown Sacramento. I would respectfully ask that, at the very least, you continue to operate either the 45 or the 230 (Ideally both!). I would drive to Davis, if necessary, to catch the 230 to be able to bus downtown. Or, alternatively, adding an earlier line onto the 42A in the morning so we can get downtown before 8:00 a.m. As of today, the 42 doesn't get downtown Sacramento until 7:42 but many need to transfer to RT or begin the workday earlier. Can you please include this email as part of the public comment on this route suspension.

With the suspension of these services it assumes that there will be no commuters working in Sacramento but living in Davis. Once these services are suspended there is no alternative public transport link other than the irregular and slow 42 service. The train link is should be a viable option but the pricing of the tickets is not reasonable at \$10 for a journey to Sacramento from Davis.

Our State desires we reduce our carbon footprint and not use our cars for single occupant trips. To meet any of these carbon goals we need to continue to offer and improve our public transport infrastructure rather than reduce it.

My concern is that once a service is suspended it is unlikely to be restarted as there will not be a business case to do so, no metrics will be available for all those that would like to use a bus if one was available.

I do not support the suspension of the service.

# **<u>RECOMMENDATION</u>**:

It is recommended that the Yolo County Transportation District (YCTD) Board of Directors:

- 1. Adopt the proposed temporary expansion of local fixed-route service as described below, and subject to changes made necessary by operational conditions, effective September 22, 2021; and
- 2. Approve FY 2021/22 Budget Amendment #1 to increase budget for the additional service.

# **REASON FOR RECOMMENDATION:**

In order to provide additional, critically needed public transit service to the City of Davis and University of California Davis (UC Davis) communities on September 22, 2021. The additional transportation demand in Davis warrants increased public transit options.

# **BACKGROUND**:

At the August 9, 2021, Board meeting, your Board approved in concept, the temporary expansion of YCTD fixed-route services in Davis adhering to the routes and schedules previously developed by Unitrans. This temporary assistance was requested due to significant recruitment challenges and reduced student driver availability due in part to impacts from COVID-19 and fewer students on campus to recruit from during the 2021 academic year. While Unitrans will continue significant recruitment efforts, their requirements to use student drivers and the limited number of hours students can work per week leads to extended training timelines. This extended training timeline would leave significant deficiencies in available transit service for the anticipated demand. YCTD had been requested to temporarily operate the A, L, and Z Line local fixed-routes in Davis to aid with the Unitrans driver shortage.

On September 1, 2021, YCTD's operations contractor informed staff that there would be insufficient permanent operators in order to meet the planned expansions of both the Route 42 and temporary local fixed-route assistance in Davis. Transdev informed staff that in order to meet the necessary operator staffing levels for the Route 42 expansion only, would require further reductions in existing service, and that meeting further expansion of service locally in Davis would likely not be possible as originally planned. Staff worked with Unitrans, the City of Davis, UC Davis and prioritized services with available resources and postponed the expansion of the Route 42 while also preparing for further suspension of fixed-route service in order to provide some level of temporary assistance in Davis.

Historically, the A, L, and Z Lines provide thousands of trips each month connecting UC Davis students, affiliates, faculty, and staff to key areas in Davis to the UC Davis main campus. With the return to full student attendance on campus during the 2021/22 academic year, complete loss of service on the corridors served by the A, L, and Z lines would result in extreme congestion from additional single occupancy vehicle travel, and potentially disproportionate impacts to those unable to afford other means of travel.

Working with known and expected Yolobus driver availability the current recommended level of service to be provided would allow for 30-minute frequency on the A Line, and 60-minute frequency on the L Line. This is reduced from the original planned assistance of 30-minute frequency on the A, L, and Z Lines and supplemental

trips from the Route 42. YCTD staff will continue working with Transdev, Unitrans staff, and our Board to frequently evaluate, prioritize, and allocate available drivers and resources to areas most in demand.

The Maps and schedules of the routes to be operated are presented in Attachment 1.

The temporary operating assistance was originally estimated to require up to 15,750 hours of service, and 213,000 miles (depending on actual need and demand). Actual hours of service and miles provided are expected to be significantly lower (approximately half) at the now proposed service levels. YCTD will be responsible for the collection of operating and performance data for the routes, as well as all required reporting to local, state, and federal agencies, as applicable.

On August 31, 2021, the City of Davis approved a Federal Transit Administration (FTA) Program of Projects allocating an additional \$70,000 (\$3,711,096 of CARES Act funding was previously allocated to YCTD) in FTA Coronavirus Aid, Relief, and Economic Security (CARES) Act funding and \$830,050 in FTA American Rescue Plan (ARP) Funding for a total of \$900,050 in FTA funds to go to YCTD to provide operating assistance on Unitrans Routes A, L and Z. Unitrans has indicated they may continue to face driver shortages into the 2022/23 academic year. With the revised service levels proposed for September 22, 2021, it is anticipated that the funding made available could be used for additional/extended operating assistance (i.e., assistance into the 2022/23 academic year). Once the Program of Projects is approved by Caltrans, YCTD will apply to FTA for these grant funds.

A budget amendment is presented in Attachment 2. This amendment increases expenses for fuel, and purchased transportation expenses. It increases FTA revenues as well.

## **BUDGET IMPACT**:

Budget Amendment #1 will increase expenses and revenues to accommodate the increase in service. Funding is coming from Davis CARES Act and ARP funds. The temporary operating assistance will not exceed the amount of funding available as identified in Budget Amendment #1.
